**\*\*\*This is a three part process with different forms:**

- ✓ **1. Delegate registration for Convention- Voting Part 1 (A) and Advisory Part 1(B) and Characterization of Voting Delegate Part 1(C).**
- ✓ **2. Payment form- Advisory delegate only - due with the returned Advisory Delegate form Part 1(B)**
- ✓ **3. Nomination and Overture Forms – Due Friday, February 26, 2021**

*Note: the NID 2021 District Convention assessment is part of the annual congregational assessment which is separately billed to congregations. Entrance and meal fees for the voting delegates are included as part of the annual congregation assessment. No separate payments are required with submission of the Voting Delegate Form Part 1 (A).*

Where there is a restriction for nomination to circuit or region, you are able to determine your specific region and circuit information on the NID website [congregation page](#).

Advisory Delegates are required in the Bylaws to attend the District Convention unless they have sent in a request to be excused. Be aware that if you are completing the form for Advisory Delegates, include only those that are intending to attend as you will be charged for each delegate that is attending. If the Advisory is not able to attend, a separate letter of excuse should be submitted.

**\*\*\***In selecting delegates, please keep in mind that **ALL** delegates must have access to email and be able to access and view convention materials on the district's website. All information and notices for delegates will be shared via email and on the website at [www.nidlcms.org](http://www.nidlcms.org), including any possible last minute convention changes.
