#### **District Bylaws**

V. B. 4.

- a. Each voting congregation shall be entitled to nominate from the ordained minister roster of the Synod: one ordained minister as candidate for president and one ordained minister as candidate for vice president. A congregation may nominate only an ordained minister from its own region for the office of vice president.
- b. Candidates for the office of president shall be the five ordained ministers receiving the highest number of votes on the nominating ballots of the congregations. Only those candidates for the office of president who have received at least five votes on the nominating ballots shall be considered for listing on the ballot of the District convention. All others receiving nominations shall be listed by the secretary of the District in the convention workbook together with the number of votes each received.
- c. Candidates for the office of vice president shall be the ordained ministers from each region receiving at least two votes on the nominating ballots. They shall be considered for listing on the ballot of the District convention. All others receiving nominations shall be listed by the secretary of the District in the convention workbook.

#### A. NOMINATIONS FOR THE OFFICE OF PRESIDENT

Forty-five District congregations submitted nominations for the office of District president. Of these forty-five ballots, four ballots were invalid, submitted after the deadline of September 26, 2024. There were forty-two valid nominations. The men, all of whom are ordained, nominated for the office of District president were as follows:

#### B. NOMINATIONS FOR THE OFFICES OF VICE PRESIDENT (BY REGION)

In the nominating process for vice president, forty congregations submitted nominations. Four were invalid, postmarked after the deadline of September 26, 2024.

#### North

Four District congregations submitted nominations for the office of vice president from the North Region. The man nominated and the number of nominations received for the office of District vice president were as follows:

Steven Anderson has served three terms as regional vice president and, under the current bylaws, is ineligible to stand for re-election. Ralph Tausz is eligible and willing to be placed on the ballot. He becomes our slate of candidates for this office.

#### West
